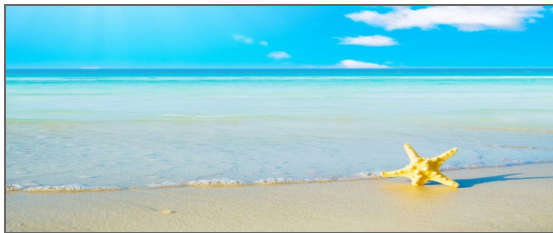

Milestones in Faculty Development

The One-Minute Preceptor: Making the Most of Your Limited Teaching Time

The **One-Minute Preceptor** model is a popular and widely used method for improving teaching skills. This model was originally designed for use by faculty in busy ambulatory practices. It facilitates efficient clinical teaching with the use of 5 “microkills” to help the mentor guide the teaching interaction. This model can be used in outpatient or inpatient settings. It also can be used by faculty teaching

residents or senior residents and team leaders teaching interns and students at the bedside.

Milestones in Faculty Development (Cont'ed):

The 5 microskills of the One-Minute Preceptor are:

1. **Get a Commitment** – i.e. ask the learner to articulate his/her own diagnosis and /or plan (*what do you think is going on? What do you want to do?*)
2. **Probe for supporting evidence** – Evaluate the learner's knowledge or reasoning (*Why you think that? What is the reasoning behind your plan?*)

3. **Teach general rules** – Teach the learner common “take-home points” that can be used in future cases, aimed preferably at an area of weakness for the learner
4. **Reinforce what was done well** – Provide positive feedback
5. **Correct errors** – Provide constructive feedback with recommendations for improvement.

Strengths of this model:

- ◆ Can be easily taught to teaching faculty and senior residents

- ◆ Focuses on few teaching behaviors (Focused)
- ◆ Easily performed
- ◆ Allows to provide immediate on the spot feedback

Application:

- ◆ Optimal for busy clinic teaching
- ◆ Great for call nights or work rounds
- ◆ Case-based format rather than didactic

Venessa Pinto, MD (PL3)

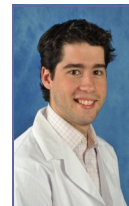
Dr. Pinto, along with Drs Ambati and Totapally, will be presenting her
